



## 2022 Directory & Calendar Amateur Photo Contest

PLEASE READ THE TERMS, CONDITIONS & GUIDELINES BEFORE SUBMITTING. ENTRIES NOT MEETING GUIDELINES WILL NOT BE CONSIDERED FOR SUBMISSION.

**How to enter:** Digital photos may be submitted by emailing your photo to [contest@prtcnet.org](mailto:contest@prtcnet.org).

**Printed photographs are no longer accepted.**

**Winners:** Winners will be notified approximately 1-2 weeks after the contest deadline by email and/or phone. Winners may also be announced on the PRTC website, social media and PRTC TV. Photographs, along with the photographer's name and information about the photo, may be displayed on the PRTC website, social media and PRTC TV.

**Submitting Photos:** Digital photos should be submitted by email to [contest@prtcnet.org](mailto:contest@prtcnet.org). Digital photos must have a minimum resolution of 2000 x 1600, photo size of 8 x 10 inches, and/or a file size of 700k or higher. Digital photos should be submitted in JPEG/JPG format (at high quality). All contest photos must be in natural color, unaltered or filtered.

**Photo Location:** The submitted photo must have been taken by a PRTC subscriber in the PRTC service area.

**Photographer/Copyright:** Entries must be submitted by the original photographer. **Do not submit a photo taken by someone other than you.** You must be the sole owner of the copyright of any photo submitted. Your submission of the photo and entry form is your guarantee that you are the sole owner.

**Entry Limit:** An individual may enter up to five photos.

**Subject Matter Restrictions:** Photos must be appropriate for public view. Obscene, provocative or otherwise questionable content will not be considered. PRTC retains sole discretion as to what constitutes inappropriate content. Photos containing recognizable people must be accompanied by a signed photo release form, included on the contest entry form.

**Ownership/Usage Rights:** Photographers retain the copyright to their photographs. By entering this contest, photographers agree to have their submitted photograph(s) be included in the PRTC Directory and 2023 Calendar. Photographers also consent to allow PRTC to display the photo(s) online and retain copies of the photo(s) for archival purposes. Photos will be credited to the photographer named on the entry form. Entries will never be sold by PRTC. In the event that ownership of any photo is contested, PRTC retains the discretion to disqualify, and discontinue use of that photograph. All photographs may be displayed on any and all of the following: PRTC's website, PRTC TV and Social Media.

PRTC and its employees, Board members and their families are not eligible to enter this contest. PRTC is not responsible for computer system, hardware, software, or program malfunctions or other errors, failures, or delayed computer transactions or network connections that are human or technical in nature. Furthermore, PRTC is not responsible for: (i) lost, misdirected, misplaced, illegible, unintelligible, incomplete, or late entries or (ii) any act, failure to act, or delay regarding the transmitting or processing of entries.
